#### **Key facts**

- 27 schools were inspected as part of the cycle 2 inspections between 2021 and 2022.
- A total of 9392 students were on the school roll during the inspection period.
- 68% of all students (6427) students were Caymanian.
- 48% of all students attended 'good' or 'excellent' schools.
- 40% of Caymanian students were attending schools that are judged to be Good or better.
- Three government schools were judged to be 'good'.
- Only 32% of all schools were performing at least at the expected level for the Cayman Islands.
- 60% of Caymanian students (3892) were attending schools that are judged to be not yet meeting the expected level of performance according to the OES 'Successful Schools and Achieving Students 2' criteria.
- All four schools judged 'weak' were in the private sector.
- 7% of Caymanian students attended weak schools.
